- <u>CONTEST PERIOD</u>: WFN's Great Gear for a Great Guy Contest (the "Contest") begins on or about 12:00 am Eastern Standard Time ("EST") on May 15, 2015 and runs through 11:59 pm EST on June 18, 2015 (the "Contest Period").
